

D-Link Reports Third Quarter 2024 Financial Results

Taipei, August 13, 2024- D-Link today announced its net revenue of NT\$3,680 million for the third quarter 2024, a decrease of 3.8% YoY; Gross profit was NT\$1,122 million, an increase of 15.6% YoY; D-Link's 3Q24 operating income was reported at NT\$172 million. D-Link's third quarter net income was NT\$183 million, net income attributable to owners of parent was NT\$178 million, and EPS was NT\$0.30.


With respect to 3Q24 consolidated revenue by product category, Switch & Security products accounted for 43% of sales revenue, followed by Wireless & IoT at 11%, Mobile & Broadband at 13%, and Others at 33%. From a geographic perspective, 3Q24 revenue contribution from Europe and America were 24% and 6% respectively, and from Asia Pacific & Others was 70%.

Note: The Company commenced controlling Cameo Communications, Inc. as a subsidiary on April 1, 2023.
